

AMENDMENT TO THE BY-LAWS  
OF  
COLONIAL WOODS HOMEOWNERS ASSOCIATION

The undersigned, the President and Secretary of the Colonial Woods Homeowners Association, hereby certify that pursuant to Section 20(B) of the Master Deed attached hereto are signatures of a majority of the co-owners approving the following By-Law amendment and the By-Laws are so amended as follows:

The By-Laws are amended by adding a section 11(v) as follows:

It is prohibited for the parking of all commercial vehicles, panel trucks, cars with any advertisement (excluding "typical" bumper-stickers), any truck larger than "1/2 ton" or any part of a truck wider than 6.5 feet wide and/or 19.5 feet long, no utility/construction type equipment or accessories are allowed (such as a wench, ladder racks, etc. with the exemption of a cargo box). Truck beds must be relatively empty, no materials shall be in view from a 20 foot distance. If topper is used, the windows must be curtained or be tinted to obstruct view of the material. No material may extend out of the boundaries of the vehicle and/or truck bed/topper at any time. Unit owners or residents may receive a temporary waiver of "material restrictions" when required for the benefit of the owners unit or Colonial Woods. An implied waiver is given for moving and/or two or three day "weekend" projects. No vehicle in whole or in part may obstruct any space or part of pedestrian or vehicle traffic ways.
